6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent/Manager of the School have individually gone through the provision contained in the affiliation and examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation and examination byelaws, directions issued from time to time and the law of the land.
